### Supplemental Terms and Conditions

#### Acquisition of Software and Support for Internal Usage

The following Supplemental Terms and Conditions - Acquisition of Software and Support for Internal Usage (“SW Terms”) supplement the Intel Corporation Terms and Conditions of Purchase Order (or, if applicable, Terms and Conditions provided by Intel’s Reseller) and are incorporated therein by this reference. These SW Terms apply when Intel licenses software and purchases related support and maintenance services. In the event of any conflict between the Terms and Conditions of Purchase Order (from Intel or its Aggregator) and these SW Terms, the SW Terms shall prevail in regard to the acquisition of software and related support services and these SW Terms govern regardless of any contrary or conflicting terms in any Licensor license agreement or similar document, however and whenever received and are hereby rejected by Licensee. For the purposes of these SW Terms, Intel Corporation and its wholly owned subsidiaries or Buyer are referred to as “**Licensee**” and Supplier or Vendor identified on the Purchase Order is referred to as “**Licensor**”.

#### 1. Definitions:

“**Reseller**” means a third party firm engaged in the distribution of third party software as a Reseller to Licensee.

“**Documentation**” means User or technical manuals, training materials, Licensed Software descriptions and specifications, license agreements, and other written information relating to Licensed Software offered by Licensor regardless of format.

“**Licensed Software**” means Licensor’s proprietary software programs expressly set forth in the Purchase Order (Licensed Software), as well as any third-party software imbedded therein, updates, upgrades, new releases or versions, error corrections, bug fixes, modifications, improvements, additions, and enhancements or other maintenance materials if provided by Licensor to Licensee hereunder, as well as the Documentation.

“**Licensed Users**” means any individual or entity authorized by Licensee to use the Licensed Software under these SW Terms, including but not limited to any third party entities such as consultants and outsource vendors of Licensee. Licensed Users include the use by Intel employees of personally owned computing devices such as tablets or smart phones when connected to the Intel network to access the Licensed Software for business purposes.

“**Maintenance**” means the provision by Licensor, during the applicable maintenance period, of any updates, corrections, bug fixes, modifications, improvements, additions, upgrades as well as new versions of the Licensed Software and/or any enhancements made to Licensed Software, and their respective Documentation that are made generally available to Licensor’s customer base.

“**Maintenance and Support Services**” means any optional services to provide Maintenance and/or Support offered by Licensor and purchased by Licensee, as defined in the Purchase Order.

“**Purchase Order**” means any duly authorized physical or electronic purchase order or similar document submitted by Licensee to Licensor in which Licensee orders Licensed Software and/or Maintenance and Support Services subject to the unmodified terms and conditions of the Agreement.

“**Support**” means the support services as set out in the Purchase Order during the twelve (12) months starting on the date of receipt of the Licensed Software unless explicitly agreed otherwise in the accepted Purchase Order.

#### 2. License Grant:

- a) In consideration of the license fees paid to Licensor under the Purchase Order, and subject to the terms and conditions of these SW Terms, Licensor hereby grants Licensee a perpetual, worldwide, non exclusive, irrevocable, fully paid up, and royalty free right and license, under Licensor’s intellectual property rights now owned or later controlled, to use the Licensed Software as listed in the Purchase Order. This license grant to Licensee includes access and use of the Licensed Software by third party entities such as consultants and outsource vendors who 1) agree to be bound by these SW Terms and 2) are an integral part of the business

processes of Licensee. The Licensed Software is licensed for internal business purposes and Licensee is not granted any rights to distribute the Licensed Software.

- b) **Licensing Model.** The mechanism, if any, by which the use of Licensed Software shall be measured, is further defined in the Purchase Order. If Licensor changes its licensing model or price structure for any Licensed Software licensed to Licensee as per the Purchase Order, e.g. "named user" instead of "concurrent user", Licensee may convert, at its sole option, to Licensor's new licensing model in such a manner that provides Licensee sufficient quantity of licenses under the new metric system as will equal Licensee's licensed use under the old metric, at no additional cost to Licensee irrespective of any conversion algorithms that Licensor may publish. Such conversion of Licenses will be agreed in writing and will not be unreasonably withheld by Licensor.
- c) **Delivery of Media and Documentation.** Licensor shall deliver the Licensed Software and Documentation to Licensee via an electronic medium or other mutually agreeable means, such delivery comprising a reasonable number of copies of the Licensed Software and Documentation, including any electronic versions of same.
- d) **Prior Version Use.** Licensee may use a previous version of the Licensed Software for which it has obtained a valid license in place of the licensed version of the Licensed Software. The license to use such prior version(s) of the Licensed Software shall be considered an extension of the License to use the licensed version of the Licensed Software and not an additional license and no additional fees or charges shall apply.
- e) **Archive/Backup:** Licensee may make a reasonable number of copies of the Licensed Software and Documentation at any location for:
  - (i) Licensed use pursuant to the License Grant, and
  - (ii) Archive, back-up or disaster recovery purposes.
- f) **Trademark and Copyright Notice:** If and when copying Licensed Software and Documentation, Licensee shall ensure that all trademark and copyright notices shall remain attached to such copies.
- g) **Limitation of Use: Except where allowed by** these SW Terms, Licensee will not:
  - (i) Sublicense, resell, market or make the Licensed Software available to any unauthorized 3<sup>rd</sup> party.
  - (ii) Use the Licensed Software for the benefit of 3<sup>rd</sup> parties
  - (iii) Use the Licensed Software in the capacity of service bureau services to any such 3<sup>rd</sup> party, except where such 3<sup>rd</sup> parties are Licensed Users
  - (iv) Modify, decompile, reverse engineer or disassemble the Licensed Software (in whole or in part) except to the extent permitted by law and these SW Terms.

### 3. Limitation of Liability:

- a) EXCEPT FOR INSURED CLAIMS, INDEMNIFICATION OBLIGATIONS HEREUNDER, OR A BREACH OF THE CONFIDENTIALITY PROVISIONS HERETO, IN NO EVENT SHALL EITHER PARTY BE LIABLE TO THE OTHER OR ANY THIRD PARTY FOR PUNITIVE, INDIRECT, INCIDENTAL OR CONSEQUENTIAL DAMAGES, HOWEVER THE SAME MAY BE CAUSED, INCLUDING FAULT OR NEGLIGENCE OF EITHER PARTY. EXCEPT FOR INSURED CLAIMS, INDEMNIFICATION OBLIGATIONS HEREUNDER, EACH PARTY'S TOTAL LIABILITY ARISING OUT OF OR UNDER THESE SW TERMS OR FOR BREACH OF THESE SW TERMS, WHETHER IN CONTRACT, TORT (INCLUDING WITHOUT LIMITATION NEGLIGENCE), STRICT LIABILITY OR ANY OTHER LEGAL THEORY, SHALL BE LIMITED SOLELY TO DIRECT DAMAGES THE LIMITATIONS SET FORTH IN THIS CLAUSE SHALL APPLY EVEN IF EITHER PARTY IS ADVISED OF THE POSSIBILITY OF SUCH DAMAGE.
- b) Notwithstanding the foregoing, nothing in these SW Terms shall exclude or limit one Party's liability to the other Party for:
  - (i) Fraud, gross negligence or willful misconduct; or
  - (ii) Death or personal injury caused by either of them, their officers, employees or any of their subcontractors.

### 4. Term and Termination

- a) **Term:** The applicable License granted to Licensee under these SW Terms shall be perpetual unless otherwise agreed by the parties. These SW Terms shall be effective from the date stated on the Purchase Order and

shall continue in effect thereafter unless and until terminated in accordance with the provisions of these SW Terms.

- b) **Termination:** In addition to any other remedies, either party may terminate the applicable License and/or the Maintenance and Support Services immediately by notice to the other party if: (i) the other party commits a breach of a material term, which is capable of remedy, and fails to remedy that breach within sixty (60) days from the date the first party notifies the other party of the breach or (ii) the other party commits a material breach of any of its obligations under these SW Terms, which is not capable of remedy.
- c) **Upon Termination for Breach based on Violation of these SW Terms by Licensee:** Upon termination for breach by Licensee becoming effective, applicable Licenses shall cease and Licensee shall, if so requested, purge or return to Licensor all copies of Licensed Software except for archive copies.
- d) **Right to Terminate Maintenance and Support Services:** Licensee may separately terminate Maintenance services and/or Support services without cause on providing the Licensor with thirty (30) days prior written notice. Termination of the Maintenance services and/or Support services shall not otherwise affect the rights and obligations of the parties.
- e) **Reimbursement of Service Fees:** Upon termination by Licensee in case of breach by Licensor, Licensor shall within thirty (30) days reimburse Licensee any fees paid in advance to Licensor in relation to Maintenance and Support Services not yet performed.
- f) The following obligations survive termination: 2.a License Grant (if and to the extent termination of the applicable License is made pursuant to a breach by Licensor only), 4 Limitation of Liability, and 7 Indemnification.

## 5. Warranty

- a) **Limited Warranty for Licensed Software.** For a period of ninety (90) days from the date on which Licensor delivers the Licensed Software to Licensee or furnishes to Licensee the key for the Licensed Software (the warranty period), Licensor warrants that (i) the Licensed Software will conform to the operational features and performance characteristics as described in the then current Documentation supplied by Licensor, and (ii) the physical media on which the Licensed Software is delivered, if any, will be free of errors and defects; provided, however, that (a) the Licensed Software is installed, implemented, and operated in accordance with the Documentation and all written instructions supplied by Licensor, (b) Licensee notifies Licensor in writing of any nonconformity, error, or defect within the warranty period, and (c) Licensee has promptly and properly installed all corrections and updates made available by Licensor to Licensee.
- b) **Exclusive Remedy.** If Licensee timely notifies Licensor in writing of a failure of the Licensed Software to conform to the warranties described above, Licensor shall at its sole and exclusive option repair or replace the Licensed Software. If the preceding remedies are not fulfilled within 90 days, Licensor will refund the price paid for the nonconforming Licensed Software, and any Support and services fees paid associated with the Licensed Software, upon Licensee's termination of its use of and rights to use such nonconforming Licensed Software.
- c) **Maintenance and Support commencement.** Where Maintenance and Support is purchased the Maintenance and Support period will commence after the warranty period expires.
- d) **Professionalism.** Licensor represents and warrants that it shall perform the Maintenance and Support Services hereunder in a professional and efficient manner, using due care, skill, and diligence and at a level equivalent to industry best standards and practices.
- e) **Authority.** Licensor represents and warrants that it has full right, capacity and authority to grant Licensee the license and rights granted hereunder, and that Licensor is not a party to any agreement that would prohibit Licensor from entering into these SW Terms or fully performing its obligations hereunder.
- f) **Authorization Codes.** Licensor represents and warrants that the Licensed Software shall not contain any authorization codes, which may prohibit access and use of the Licensed Software according to the permitted use, data or other software or hardware associated with it.
- g) **Viruses and Harmful Codes.** Licensor represents and warrants that Licensor has used, and will continue to use, commercially reasonable measures to ensure that the Licensed Software does not contain any virus, malicious code, monitoring or metering devices, program or other internal component (e.g. Computer worm, computer time bomb or similar component) (hereinafter the "Harmful Code") which could (i) damage, destroy or

alter the Licensed Software or its operating environment; (ii) hinder Licensee's ability to use the Licensed Software or any hardware associated with it; (iii) in any manner, reveal, damage, destroy or alter any data or other information accessed through or processed by the Licensed Software, or; (iv) in any manner, damage, destroy or alter Licensee's information systems or data and other information accessed through or processed by Licensee's information systems.

- h) **Third Party Software.** In the event Licensor provides any third party software (the "Third Party Software") to Licensee in connection with these SW Terms, the following shall apply: (i) Licensor shall specifically identify in writing all Third Party Software, and (ii) Licensor represents and warrants that (a) it has the right to license any Third Party Software licensed to Licensee under these SW Terms; (b) the Third Party Software does not, and the use of the Third party Software by Licensee, as contemplated by these SW Terms, will not infringe any intellectual property rights of any third party; and (c) unless specifically provided otherwise herein, Licensee shall have no obligation to pay any third party any fees, royalties or other payments for Licensee's use of any Third Party Software in accordance with these SW Terms. Licensor shall maintain and Support all such Third Party Software to the same extent as the Licensed Software.
- i) **Warranty Disclaimer for Licensed Software.** EXCEPT FOR THE EXPRESS AND/OR LIMITED WARRANTIES AND REPRESENTATIONS PROVIDED HEREIN BY LICENSOR TO LICENSEE, LICENSOR HEREBY DISCLAIMS ALL WARRANTIES, BOTH EXPRESS AND IMPLIED, INCLUDING IMPLIED WARRANTIES RESPECTING MERCHANTABILITY, AND FITNESS FOR A PARTICULAR PURPOSE. SOME JURISDICTIONS DO NOT ALLOW DISCLAIMERS OF IMPLIED WARRANTIES, SO THE ABOVE LIMITATION MAY NOT APPLY TO LICENSEE THE LIMITED WARRANTIES DESCRIBED HEREIN GIVE LICENSEE SPECIFIC LEGAL RIGHTS, AND LICENSEE MAY ALSO HAVE OTHER RIGHTS THAT VARY FROM JURISDICTION TO JURISDICTION. NOTWITHSTANDING ANYTHING TO THE CONTRARY, LICENSOR DOES NOT WARRANT THAT THE LICENSED SOFTWARE WILL MEET LICENSEE'S REQUIREMENTS, THAT THE LICENSED SOFTWARE WILL OPERATE IN THE COMBINATIONS WHICH LICENSEE MAY SELECT FOR USE, THAT THE OPERATION OF THE LICENSED SOFTWARE WILL BE UNINTERRUPTED OR ERROR-FREE. EXCEPT FOR LICENSOR'S EXPRESS REPRESENTATIONS HEREIN, LICENSEE UNDERSTANDS AND AGREES THAT LICENSED SOFTWARE IS NO GUARANTY AGAINST INTRUSIONS, OR THAT ALL SECURITY THREATS AND VULNERABILITIES WILL BE DETECTED OR THAT THE PERFORMANCE OF THE LICENSED SOFTWARE WILL RENDER LICENSEE'S SYSTEMS INVULNERABLE TO SECURITY BREACHES.

## 6. Indemnification

- a) **Infringement Indemnification.** Licensor shall, at its sole expense, indemnify, defend and hold Licensee and directors, officers, employees, shareholders and agents and all of their respective successors and assigns, and Licensed Users (the "Licensee Indemnified Parties") harmless from and against any and all Claims, actual or alleged, arising in favor of any person or entity for or as a result of infringement or alleged infringement of any patents, copyrights, trademarks, misappropriation and/or misuse of any trade secrets, confidential information or other intellectual property right, based on or related to the operation or use of the Licensed Software and/or any Maintenance services associated therewith. In connection therewith, Licensor shall at its sole expense, promptly undertake to procure for Licensee Indemnified Parties, the right to continue using such Licensed Software and/or Maintenance services without unreasonable interruption or loss of functionality or performance. If, however, such right cannot be procured within ten (10) business days of notice of such Claim on terms and conditions reasonably acceptable to Licensee Indemnified Parties, Licensor shall, at its sole expense but at Licensee Indemnified Party or Parties' discretion: (i) promptly modify such Licensed Software and/or Maintenance services to render it non-infringing but functionally equivalent, or (ii) promptly substitute the Licensed Software and Maintenance services with a replacement that is non-infringing but is functionally and performance-wise equivalent. In the event that Licensor, using its best efforts, is unable to remedy the infringement within an agreed timeframe with any of the foregoing options, then it shall promptly refund to Licensee Indemnified Parties the sums actually paid for using the Licensed Software and Maintenance services, and Licensee shall cease its use.
- b) **Indemnification Procedure.** Licensee Indemnified Party shall have the right at its discretion and sole cost to be represented by its own counsel and to participate in the defense of any action in which a Licensee Indemnified Party is named as a party defendant, and the Licensee Indemnified Party's prior written approval will be required for any settlement that reasonably can be expected to require a material affirmative obligation of or, result in any ongoing material liability to a Licensee Indemnified Party.

## **7. VERIFICATION OF COMPLIANCE**

If Licensor has reasonable cause to suspect a breach by Licensee of any of its licensing obligations under these SW Terms, Licensor may request a written certification from Licensee executed by a Licensee executive responsible for such Licensed Software which verifies Licensee's compliance with these SW Terms or, if applicable, identifies any noncompliance and commits to correct same as soon as practical and to recertify that such correction has been implemented.
